- 1. Eligibility. The Eagles Checking Giveaways ("Sweepstakes") is only open to legal residents of the United States who are currently living within Pennsylvania, New Jersey, Delaware or Maryland who are 18 years of age or older at the time of entry ("Entrant"). Employees, officers and directors of Firstrust Bank and its subsidiaries (the "Sponsor"), their immediate families (parent, child, sibling & spouse and their respective spouses, regardless of where they reside) and persons living in the same households as such individuals (whether related or not) are not eligible to participate in the Sweepstakes.
- 2. Timing. The Sweepstakes begins accepting entries at 12:00:00 am ET on August 1, 2022 and stops accepting new entries at 11:59 pm ET on January 31, 2023 (the "Promotion Period"). For the purposes of this Sweepstakes a day is defined as a calendar day beginning at 12:00:00 am ET and ending at 11:59:59 pm ET. Sponsor's computer is the official time-keeping device for the Sweepstakes.

3. How to Enter.

• AUTOMATIC ENTRY: An eligible Firstrust Eagles debit cardholder will automatically receive one (1) Sweepstakes entry for each eligible Visa purchase, made during the Promotion Period at a participating merchant location in the U.S. Only eligible Visa purchases, or payments made with a Firstrust Eagles debit card that is not in default under the customer agreement for that account and issued by Firstrust Bank, processed through Visa U.S.A. Inc.'s transaction-processing system during the Promotion Period, are eligible for automatic entry. In the event of a dispute as to who submitted a particular cardholder entry, such entry will be deemed to be submitted by the primary person in whose name the card used to enter the Sweepstakes was issued. Account adjustment transactions/returns, non-U.S.-dollar purchases, Interlink®-processed transactions, payment of late fees or over-limit fees, are excluded from automatic entry. Other restrictions and exclusions may apply. Visa cards or card numbers that are stolen, fraudulent, tampered with, or otherwise altered are not eligible for automatic entry. Automatic entries must be made by the last day of each month to be eligible for each month's drawing.

Incomplete entries or entries not complying with these Official Rules are subject to disqualification, at the Sponsor's sole discretion. Proof of mailing does not constitute proof of delivery.

Sweepstakes Drawing.** One winner will be selected on by the 10th of each month, (January 10, February 10, March 10, April 10, May 10, June 10, July 10, August 10, September 10, October 10, November 10 and December 10 of each year. Winners are picked based on prior month transactions and do not carry over to the next month. Each month entries are for debit card purchases from the first day of the month until the last day.

By entering, you grant permission to be contacted by Firstrust Bank via email, mail or telephone in connection with the Sweepstakes, although you may opt out of receiving such materials at any time. You must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements set forth herein. A potential winner is not an official winner ("Winner") until the potential winner's eligibility has been verified and they have been notified. Sponsor's decisions are final and binding in all matters related to the Sweepstakes.

5. Winner Notification: The potential winner will be notified by phone, mail or email within three (3) business days of the drawing. If a Potential Winner cannot be contacted or has not responded within five (5) days of the drawing, or he/she refuses his/her prize for any reason, such Potential Winner will be disqualified and Sponsor will select an alternate Potential Winner by random drawing from all remaining eligible Entries. If Potential Winner of the monthly prizes fails to execute the requested documents within 14 days of receipt of notification, he/she shall forfeit the prize and an alternate Potential Winner will be selected at random from the remaining eligible Entries. By accepting a prize, you grant permission for Sponsor and its designees to use your name, address (city and state), photograph, voice and/or other likeness and prize information for advertising, trade and promotional purposes without further compensation, notice, review or approval in all media now known or hereafter discovered, worldwide in perpetuity.
