



## Ardmore Days – 10/2/21

### OFFICIAL RULES

#### NO PURCHASE, ACCOUNT RELATIONSHIP OR TRANSACTION NECESSARY TO ENTER OR CLAIM A PRIZE.

**1. Eligibility:** This Sweepstakes is only offered in Pennsylvania and entrants must be legal U.S. residents 18 years of age or older as of the first date of the Promotional Period as defined below. **6. Notification:** The winner will be notified by telephone, email, or certified mail (return receipt requested) within five (5) business days after the drawing. The prize will be mailed to the winner. Firsttrust Bank reserves the right to require an Affidavit of Eligibility and Liability Release each of which must be returned within ten (10) days from the request by sponsor for such Affidavit or Release. In the event of non-compliance with these rules, or if the prize or prize notification is unclaimed or returned as undeliverable, the prize will be forfeited and, at Sponsor's discretion, awarded to an alternate winner.
